Q. Do you support the proposed federal End Racial Profiling Act?

A. Yes. I support efforts to eliminate racial profiling.

Q. Do you support adding a prohibition on profiling on the basis of religion to the United States Justice Department Guidance on Racial Profiling? -

A. Yes. I have sent numerous letters to the Department of Justice on this matter.

Q. Do you support the proposed Federal Safe Schools Improvement Act?

A. I oppose bullying, especially on the basis of race. I have twice co-sponsored the Safe Schools Improvement Act and have hosted several anti-bullying events in my district.

Q. Do you support a change in United States military policy so that Sikhs would have an opportunity to serve our military while maintaining their turbans and uncut hair without requiring them to seek special, hard to obtain, revocable accommodations in order to do so?

A. I believe that we should not discriminate against individuals who wish to serve in our armed forces and defend our nation. I sent a letter to the Department of Defense requesting that it review current uniform code policies so that Sikhs are not discriminated against based on their religion.

Q. Will you encourage law enforcement agencies in your Congressional district to allow Sikhs to serve as police officers without removing their religiously-mandated turbans and uncut hair?

A. I support efforts to allow Sikhs to serve as first responders.

Q. Do you agree that thousands of Sikhs were murdered in India in November 1984 with the assistance of or lack of intervention by political parties, law enforcement, military or members of the government?

A. Yes. The events of 1984 are tragic. As an international community, we must ensure that these types of terrible acts do not happen again.
